

Terms of trade and subscriptions.

Thank you for purchasing our Safety Guard GPS tracker ☺

Safety Guard GPS operates by finding your location in regards to the positions of the GPS satellites.

The determined position is send to our server via the GSM mobile network. When the server receives the position we will update the location on your APP / PORTAL. Therefore you can only use a subscription purchased from Dantracker

Acceptance of subscription service

With the acceptance of these terms, you agree to automatic renewal of your subscription. This means that Dantracker Technology Company ApS automatically withdraw your chosen subscription payment amount, periodically, when your chosen period of 1, 6, 12, 24 or 36 months has expired. Your subscription will automatically renew on the date on which it expires and the money is automatically drawn from your account. Furthermore you accept, that Dantracker Technology Company ApS can send service announcements to the given email address.

Setup fee

The first time you buy a subscription to your tracker, you will be charged a setup fee. The price is displayed in connection to the payment. If the subscription has been canceled, a new setup fee will be charged with a new subscription.

Payment cards

The following Payment cards are accepted at www.Dantracker.com: Dankort, MasterCard, Visa and Visa Electron. The amount will be withdrawn automatically from your account, once the "Terms of trade and subscriptions" has been accepted.

Security on www.dantracker.com

Dantracker Technology Company ApS use DanDomain paymentsystem for payment transactions. DanDomain paymentsystem meets all the safety requirements, there has been, approved and certified by Nets. All communication between DanDomain Payment and the cardholder is made via an encrypted SSL connection. This ensures that unauthorized personal has no access to the data being exchanged. Similarly, data sent between DanDomain Payment and Nets payment server are encrypted.

Use of credit cards at DanTracker.com is safe and approved by Nets.

DanTracker Technology Company ApS has no access to your credit card information.

Certain payment card's has a three-digit security code in addition to the card number and expiration date. Nets need this code to check the payment card. You will find the security code on the back of the payment card in the bottom right corner.

Privacy Policy.

You can feel safe when you register your personal information on dantracker.com. Dantracker Technology Company is responsible for the collection and management of data, and we emphasize that Dantracker Technology Company does not sell or distribute the information to others.

The information is stored indefinitely, or untill you delete your user profile.

Data exchange

You are informed and have agreed that Dantracker Technology Company stores your data (including positions).

You are familiar with Safety Guard GPS communicating with our server and forwarding the information to your user account, or APP, via the electronically subscription.

To the extent that you are handing Safety Guard GPS with subscription over to others, it lies to you to inform of the Trade and Subscription Terms.

You further understand that Dantracker Technology Company carries out regular functional testing and updating of systems and in doing so seek and exchange physical positions on the connected equipment. Furthermore, you agree that Dantracker Technology Company system obtain and communicate data to be processed, and stored, also location data and movement patterns that Dantracker Technology Company is entitled to communicate (in anonymous form f.example for statistical purposes), when these data are not inconsistent with the Privacy Act, for example sensitive information and information about other purely private matters. Newest received position is saved on Dantracker Technology Company server until the end of the subscription.

Cardholder responsibility and liability.

The subscription is mandatory from the moment it is setup and the money is withdrawn from your account. The cardholder is required to pay the full amount for the whole of the selected subscription period and subsequent subscription withdrawals, unless the subscription has since canceled (see rules for termination).

Change of address.

Change of address must be notified Dantracker Technology Company via the user profile on Dantracker Technology Company's website within 14 days after the address actually changed. It is your sole responsibility to manage personal information in the user profile (eg. phone no., Email, address) so that Dantracker Technology Company has the opportunity to contact you.

Termination of Subscription.

You can always terminate the subscription agreement with the effect from the billing period expiration, unless otherwise specified in a special agreement with Dantracker Technology Company.

Dantracker Technology Company will close the connection at the same day the subscription agreement ends, if the subscription is terminated or the amount of a new period cannot be withdrawn. You are obligated to pay all costs until the subscription termination. Termination of subscription agreement must be in writing via the website www.dantracker.com

If a subscription is terminated Dantracker Technology Company will not make further withdrawals from your account in the future.

Commitment period.

Your commitment period for the subscription is identical to your remaining time of the payment period, regardless of how long your subscription is or when you purchased your subscription.

Continuation of subscription.

If your tracker runs out of battery and you would like to continue to get the positions of your Item. You can find your local dealer and buy a new tracker, and via www.dantracker.com transfer your subscription to this new tracker and retain the paid subscription period.

Return Policy

You can always return a Safety Guard GPS in unopened original packaging.

It shall be returned to the dealer where it was purchased, unopened and with receipt.

Your subscription purchase, is subject to the statutory withdrawal period of 14 days.

You can only withdraw if your subscription is not taken in use within the 14 days.

You take your subscription in use as soon as you complete your purchase by www.dantracker.com.

Do you want to use this right, you must immediately after purchase log off and not sign in again and contact customer service to inform, that you regret your purchase.

Warranty

You automatically have a 2 year warranty on your GPS Safety Guard, from the date on which you create and buy the subscription. The warranty is automatically calculated on our website, where you also have the opportunity to complete an RMA request to Dantracker.

Calculations show that a Safety Guard GPS, can last up to 10 years (Stand-by), or approx. 14,000 GPS tracks under optimal conditions. Dantracker cannot guarantee these numbers as figures obtained by test and calculation. Therefore a limited warranty of 2 years from the date the product is applied.

Support

As long as your Subscription runs, you have the opportunity to receive e-mail support within Dantracker Technology Company regular business hours. All queries are processed in the order they enter.

Compensation

Dantracker Technology Company cannot at any time be held liable for direct or indirect loss arising from the use of our products.

Functionality of the system

Dantracker Technology Company does not guarantee - and is not responsible whether a given object under a subscription agreement can actually be found.

NOTE: Safety Guard GPS is made with traditional standard technology and can only forward its position if the location is within GSM mobile network coverage, and the antenna can receive signals from satellites and cellular towers.

Disputes

Disputes between Dantracker Technology Company, and buyer is sought solved amicably. If this fails, either party may refer the dispute to the Danish courts for full and final settlement.
